- Applicant(s) need to click on 'Click Here to Apply' link pertaining to the Course in which He/She is seeking admission. Submit it and pay Prospectus fee.

- You can fill multiple applications for different courses if you are applying for first year.
- You cannot fill multiple applications for same course with same reservation
- You can delete any application that is not yet submitted or paid
- Few details on the application form cannot be edited (highlighted in the application) if you are filling multiple applications, if college has already verified any one of your application.
